Parking

Parking is a real problem for our school like many others both in Peterborough and nationally. We are actually very lucky, having so many parking bays directly outside the school on Wistow Way and in addition, have use of a car park so close to the school.

Despite these provisions and numerous requests we still see illegally and badly parked cars daily outside the school.

The double yellow lined areas along Wistow Way are only on sections that are dangerous to park, such as on the long corners and opposite the parking bays and traffic calming measures. Parking on any of these areas is extremely dangerous and ultimately could result in someone being injured.

The school has an obligation to provide all the children and their families a safe environment both in and around the school, and we will continue to work with the local Police and Council to ensure safety on the roads. It is not the responsibility of the school to provide parking for parents, simply to maintain the safety of our children and promote legal and safe parking.

Curriculum Evening

- Financial considerations are fully taken into account in reaching decisions.

In practice this means that I carry out regular checks of invoices, receipts and general accounting to do with the running of the school. To maintain the independence and integrity of the role I am not a voting member of the Resource Committee.

- The Head then joins the meeting to hear feedback and clarify understanding from evidence pack regarding 2010 2011 performance, and the collected parties agree new objectives, and measurement criteria for 2011 2012.
- A formal recommendation on the Heads remuneration and supporting documentation is then made to the Salaries Sub-Committee, made up of; Steve Parrott (Chair of Governors), Carly Pearson (Chair of Teaching & Learning Committee) and Mark Hutchins (Chair or Resources Committee).
